Survey Summary Fees & Rates - Dancers

This is a document to summarize the data collected from Dancers Engaged in Dance Work, with information relevant to past two years, 2009-2011. This information is based on the 51 surveys completed.

CADA/BC Membership, Documents & Services (1, 84-91)

Among the 50 Dancers surveyed, 90% (45) are currently CADA/BC members, while the other 10% is comprised of non-members or those who plan to join. There is a strong correlation between those who hold a membership and those also taking advantage of the documents and services that CADA/BC offers to the dance community. As demonstrated in the survey, 75% of all members use at least 3-4 of the documents or resources offered by CADA while among the non-members, only 2 Dancers utilized a combination of the 1-2 of the documents or resources. The figure below illustrates the utilization of these Documents and Services for both Members and Non-Members.




Feedback was generally positive when asked about cadabc.org and Community Zero. Most appreciate the information available regarding classes & workshops, auditions and other dance opportunities. The ability to post and access other postings is popular among dancers, as it promotes involvement in the dance community. However, a few comments indicate that cadabc.org and Community Zero can be occasionally awkward to navigate & not maintained with up to date information.

Genre, Training & Career (2-5)

Vancouver, the Lower Mainland & centres with populations upwards of 100,000 are the place of residence for 90% of the dancers surveyed. A small amount live in centres with populations less than 100,000 or split time between both.

The percentages are quite balanced when looking at those dancers just entering their professional career (under 2 years) and those who have been working professionally for over 20 years. However, the bulk of dancers surveyed fall into the category of 2-20 years of professional work.

Contemporary was shown to be the predominant style in which most dancers work professionally (90%), with Dance & Media, Ballet & Urban accounting for 60% of professional work. Interestingly, most of the CADA/BC Members (96%) work professionally within the Contemporary genre. Aboriginal, African, Classical Spanish, European Folkloric & Percussive styles account for a small amount of professional work, occupying only 14%.



In keeping with this theme, the majority of dancers train in contemporary, or a combination of 2 or more styles including Ballet, Urban and Yoga/Pilates. Training in other styles (Aboriginal, African, Classical Spanish, European Folkloric & Percussive) once again, accounts for only a small percentage.

PAY - Rehearsal (6-29)

Dancers were asked to identify if the payment they received for rehearsal time fell below, within, or above the CADA/BC Professional Standard Range for Hourly & Weekly Rehearsal over the past two years. Dancer Exclusivity & Apprentice rates were also documented. It should be noted that most Dancers have been paid a combination of rates (ranging from below-above), with a fair percentage not having been compensated in either manner within the past two years. Overall, the majority of payment fell either within or below the Standard Range, with a small percentage exceeding the Range.

The CADA/BC Professional Standard Range for Hourly Rehearsal:

\$22 - \$30 / hour

Dancers paid within: 35.9% (average \$24.85/hour over 5 engagements)

Dancers paid below: 73.5% (average \$18.20/hour over 5 engagements)

Dancers paid above: 20.6% (average \$96.25/hour over 5 engagements)

The CADA/BC Professional Standard Range for Hourly Rehearsal, Apprentice Rate:

\$13.50 - \$18 / hour

Dancers paid within: 7.7% (average \$16.00/hour over 5 engagements)

Dancers paid below: 45.5% (average \$0.00/hour over 5 engagements)

Dancers paid above: 0.0% (no data)

The CADA/BC Professional Standard Range for Weekly Rehearsal Fee:

\$550 - \$1000 / week

Dancers paid within: 60.0% (average \$713.20/week over 5 engagements)

Dancers paid below: 47.1% (average \$412.80/week over 5 engagements)

Dancers paid above: 5.9% (no data)


The CADA/BC Professional Standard Range for Dancer Exclusivity Rate:

\$797.50 - \$1087.50/week

Dancers paid within: 7.7% (average \$975.00/week over 5 engagements)

Dancers paid below: 20.0% (average \$525.00/week over 5 engagements)

Dancers paid above: 0.0% (no data)



PAY - Performance (30-37)

Dancers were asked to identify if the payment they received for performance fell below, within, or above the CADA/BC Professional Standard Range for Performance over the past two years. Although most Dancers have been paid a combination of rates ranging from below to above the Standard Range, the great majority have been consistently paid within the CADA/BC Professional Standard Range for Performance.

The CADA/BC Professional Standard Range for Performance:



Dancers paid below: 55.6% (average \$52.60/performance over 5 engagements)

Dancers paid above: 13.0% (average \$758.3/performance over 5 engagements*)

PAY - Choreography (38-60)

Dancers were asked to identify if the payment they received for Choreography fell below, within, or above the CADA/BC Professional Standard Range for Choreography over the past two years. The data shows that most Dancers have been paid within or below the Professional Standard Range for Choreography in each of the following methods of compensation. As indicated through survey responses, the most popular method to compensate choreographers is per completed minute of choreography and in-studio rehearsal.

The CADA/BC Professional Standard Range for Choreography per Completed Minute of Choreography: \$150 - \$300 / minute

Choreographers paid within: 37.5% (average \$194.4/minute over 5 engagements)

Choreographers paid below: 50.0% (average \$57.50/minute over 5 engagements)

Choreographers paid above: 7.7% (no data)

The CADA/BC Professional Standard Range for Percentage of Budget Choreography Fee:

Minimum of 20% of Budget

Choreographers paid within: 11.1% (no data)

Choreographers paid below: 50.0% (average 7.5% of Budget over 5 engagements)



\$906.25 - \$2000.00/week

Choreographers paid within: 16.7% (average \$1,000/week over 5 engagements)

PAY - Royalties (61-66)

Dancers were asked to identify if the payment they received for Royalties fell below, within, or above the CADA/BC Professional Standard Range for Royalties over the past two years. 100% of Dancers indicated that they had not been compensated in this manner for royalties in the past two years.

The CADA/BC Professional Standard Range for Royalties:

1% - 10% of the original fee paid for the work

PAY - Rehearsal Direction (70-75)

Dancers were asked to identify if the payment they received for Rehearsal Direction fell below, within, or above the CADA/BC Professional Standard Range for Rehearsal Direction over the past two years.


The CADA/BC Professional Standard Range for Rehearsal Direction:

\$22-\$30/hour

Teachers paid within: 20.0% (average \$25/hour over 5 engagements)

Teachers paid below: 75.0% (average \$8.5/hour over 5 engagements)

Teachers paid above: 37.5% (average \$50/hour over 5 engagements)



PAY - Teaching (67-69)

Dancers were asked to document their past 10 teaching engagements and provide the rate range payment fell into. The data has been organized by level of class taught & inclusive of all 10 engagements. The rate range that most payment falls into is highlighted in the table below.

The CADA/BC Professional Standard Range for Teaching:



PAY - Overtime (77-80)

The table below outlines whether or not Dancers have been paid for overtime while performing, choreographing, teaching & directing rehearsal over their past 5 engagements. It is evident that the majority of dancers surveyed have not been compensated for overtime in these situations, however many individuals indicated that overtime was not relevant.



Additional Comments

Offered work within the Opening/Closing Ceremonies, but declined due to lack of payment

Adverse financial affect due to the interference of dance activities; The Olympics pulled focus

Stopped dancing for the duration of the Games

Commissioned for municipal choreographic contracts which were well paid

Looking for dance work elsewhere since the Olympics

Contracts (82-84)

In regards to working with or without a contract, many dancers would engage in work with the absence of a contract (66.6%). Of the Dancers who would work without a contract, 25.0% indicated that this option was preferred only 'sometimes', with another 19.4% specifying that this choice would be made only if working for friends.

Although in practice, over the past two years the majority of dancers (71.1%) have worked with a contract for over half of their professional engagements. As mentioned under the Document and Services heading, the Dance Agreement provided by CADA is used by more than half of those surveyed (all CADA Members & those planning to join).
